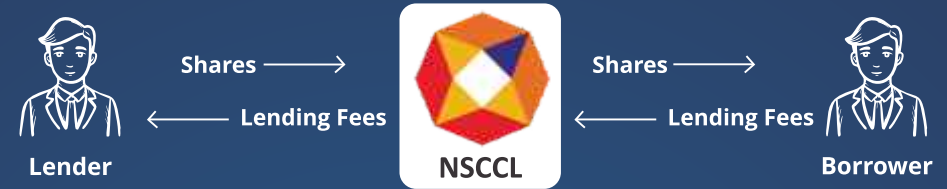
What Is SLBM ?

- Borrower would use these stocks to facilitate his trading and arbitrage strategies.

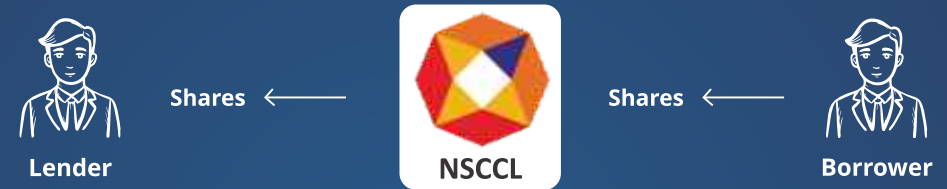
SLBM Process Flow
